When active duty calls, DaVita supports its reserve and guard members through the Star Troopers Program, continued health care coverage and the DaVita Village Network, which can provide up to \$5,000 in financial assistance each year. There are also options for paid military leave.

DaVita's Village Veterans team, made up of company leaders who are military veterans, also assists in the onboarding process for new hires through a mentorship model that allows teammates to ask for advice and help as well as general questions to assist in making their transition successful.
