Finally, they have been working on creating a patient-safety focused usability guide that will help standardize aspects of EHRs. This would not only improve patient safety, but also provide clinicians with a more cohesive experience between EHRs.

Ms. Stech's role as Product Manager for Falcon Physician has allowed her to work toward improved EHR usability for nephrologists over the past two years. She has worked with dozens of providers, studying their workflow and needs in order to improve Falcon tools in order to ultimately benefit care quality. Her new position with the EHR Association utilizes this experience to benefit health care as a whole.
