

# Falcon Physician weighs in on usability at EHRA Summit: Providers and Software Developers Collaborate to Improve EHR Usability

This forum facilitated real conversation about EHR usability, its strengths and weaknesses, and why this technology is worth investing in. Ultimately, the work we are doing will help save lives."

Wayne Riley, MD, MACP, president of ACP, was enthusiastic about the commitment of these organizations. "We are very pleased to see that so many busy professionals are willing to take a day to help us move forward on this important issue. Part of the usability challenge is to meet the needs of different specialties, varying physician workflows, and patient populations with vastly different care delivery requirements."
